- **QuickBooks Online app for Windows and Mac: The QuickBooks Online app for Windows and Mac ("app") requires a Windows PC or Mac computer with a supported browser (see System Requirements for a list of supported browsers) and an Internet connection (high-speed recommended). The app is available for QuickBooks Desktop migrators with an active QuickBooks Online Simple Start, Essentials, Plus or Advanced subscription. Multiple company tabs allow for simultaneous sign in across multiple company files. Access to each company file sold separately. - **QuickBooks Online Payroll: Additional terms, conditions, and fees apply.
- **Continued access to QuickBooks Desktop: Available only on QuickBooks Desktop 2023 R3 or newer, view-only access remains for 1 year after your subscription ends. In that time, you won't be able to edit your data with your inactive license, but you can renew your subscription or export your data. To view your data after 1 year, you'll have to renew your subscription. We recommend you export your data or migrate data to QuickBooks Online before you cancel your Desktop subscription.
