Prosperity Quest Terms of Service

Prosperity Quest (the "Game") is a web-based game owned by Intuit Inc. ("Intuit", "We", "Our"), available through the [Intuit for Education Platform](#) or provided directly to users by Intuit through an Intuit for Education related program or challenge. By accessing or using the Game, you agree to be bound by the following Terms of Service ("Terms" or "TOS") in addition to the [Terms of Service](#) that govern the Intuit for Education Platform (the "I4E Terms of Service"). Please read them carefully before accessing the Game.
