Q: Can I use Workpapers and Pro Tax for clients without a QuickBooks Online account?


You can use Pro Tax even if your client is not currently using QuickBooks Online. However, you can only use Workpapers for clients with a QuickBooks Online account.

Q: How does the Pro Tax free trial work?

You can create up to seven T1 returns and seven T2 returns per firm for free with your Pro Tax trial! You will need to subscribe when it's time to EFILE, print, or export your return.
