### **Reclassify Transactions**

Your clients may need to edit multiple transactions such as update the tax or move them to a different account. In QuickBooks Online Advanced they can reclassify multiple transactions in a single step instead of one at a time.

#### How to reclassify transactions

- 1. Open your client's QuickBooks Online.
- 2. Select Settings and then Reclassify transactions.
- From the Account types dropdown menu, select Profit and loss to see income and expense accounts. Or select Balance sheet to see your asset, liability, and equity accounts.
- **4.** From the Account list, select the account with the transactions you want to change.
- **5.** Use these type, class, customer/supplier, and modify filters to filter the list.
- Tip: You can also select Accrual to see all paid and unpaid transactions or Cash to see only paid transactions.

#### 6. Select Find transactions.

- **7.** Tick the box for each transaction you want to change.
- Note: If you don't see Change location to, you may need to set up locations for your account.

**Important:** Before you move transactions to Accounts Receivable or Accounts Payable, make sure there's a customer or supplier. Don't leave these fields blank.

- Select a new account to move the transactions to from the Change account to dropdown, or a new class from Change class to dropdown.
- **10.** When you're ready, select **Apply**.


### Tasks

Tasks help your clients manage what work needs to be completed and by when. They can create one-off tasks or set up tasks that recur regularly. Best of all, tasks can help your clients organise their work in one central location so nothing falls through the cracks.

Where defined, the new Workflow feature in QuickBooks Online Advanced can automatically create tasks for team members to complete. Using Tasks, you can:

- Create tasks for yourself.
- Create tasks for team members where permissions allow.
- Automate tasks from Workflows.
- Create recurring tasks.
- Upload documents to tasks.
- Add comments to tasks.





#### How to reclassify transactions


- **1.** Go to the **Tasks** menu.
- 2. Select +Add task.
- 3. Enter the task name and set the due date.
- 4. In the Assign to dropdown, select the task owner.
- Note: The user needs to have admin access.
- 5. (Optional) If you'd like the task to repeat, turn on Recurring task. You then have the option to set the task to repeat on certain days of the week, month or year. Choose the option that works best for you.
- **Tip:** To change/delete a recurring task, select **Edit recurring task** or **Delete recurring task**.
- 6. In the Notes field, enter a description. These are the instructions for the task.
- 7. To upload a file, select Upload document.
- Note: Documents uploaded here are visible to all users of your company. Or, select Select document to fetch files that are already in QuickBooks.
- 8. Then select Save.



### Workflows

With QuickBooks Online Advanced, your clients can use workflows to automate common tasks in QuickBooks like sending payment reminders or new invoices to customers. They can also send reminders to their team to complete specific tasks like reviewing open invoices. Automating tasks with workflows saves time so they can focus on their business. You can streamline the following using workflows:

- Automate key accounting tasks.
- Set reminders for transactions like invoices, payments, or deposits with a due date.
- Notify customers when their payment has been received.
- Route invoices on pre-set approval flows quickly.
- Setup custom templates.



#### How to create custom workflows

- 1. Select the Workflows menu. Or select Settings ôg and then Manage Workflows.
- 2. Select the Templates tab.
- 3. Select + Custom workflow to create a new template.
- In the ▼ dropdown for Select record for workflow, select the transaction type.
- In the Define action that you'd like QuickBooks to do section, select action. The options that display depend on the type of transaction you select.

#### Select Next.

- **7.** In the **Workflow name** field, enter a name for the template.
- 8. Complete the fields in the window.
- When you're done, select Save and enable to turn on your workflow.

### **Employee Expense Claims**


Your client's team members can now submit their expenses and upload receipts for review by their manager in QuickBooks Online Advanced. This helps them track and record employee expenses in one place. Using employee expense management;

- Team members can submit expenses and record receipts.
- Managers can review, track, and store employee expenses in one location.
- Managers can be notified when their employees submit expenses for review.

#### Giving employees access to submit expense claims

Firstly, before employees can submit expense claims, they have to be set up as a QuickBooks Online user. Next, they need to be given access to submit expenses claims and there are 2 ways your clients can give their employees access to submit expense claims in QuickBooks Online Advanced:

- 1. Assign access from the manage users option by using a role which provides access to expense claims
- In QuickBooks Online, select Settings 
   <sup>(3)</sup>, then select Manage users.
- 2. Select Add user, then enter the employee's name and email address.
- Note: Special characters aren't allowed other than a period in the user's name. For the email field, you can use a period and the @ symbol.
- Select the Roles ▼ dropdown, then select the role, Track time and submit expense claims.
- **4.** Review the features this role gives access to. You can expand each section.
- In the time tracking section, select sync team member to link this user to an employee or supplier record in QuickBooks.
- Choose from existing employees and suppliers present in your QuickBooks or choose to add a new one by selecting + add new.
- 7. A right side drawer opens where you add the new supplier or employee. Switch between adding a supplier or employee using the contact type field at the top of the drawer.



- **8.** Enter contact details of the supplier or employee, then select **Save**.
- **9.** With the employee or supplier details entered, they will now appear in the sync your team member popup and select **Sync**.
- 10. Select Send invitation.

#### 2. Assign access from the expense claims page

- **01.** In QuickBooks Online, go to **Expenses**, then **Expense claims**.
- **02.** Select Manage settings.
- **03.** Select Manage users.
- **04.** Here, you can see a list of employees who have been assigned expense claims access.
- 05. Select Add user.
- **06.** You will be redirected to the add user page where you can enter the employee's name and email address.
- Note: Special characters aren't allowed other than a period in the employee's name. For the email field, you can use a period and the @ symbol.
- **07.** The **track time and submit expense claims** role will be pre-selected.
- **08.** Review the features this role gives access to. You can expand each section.
- **09.** In the **time tracking** section, click on **sync team member** to link this user to an employee or supplier record in your QuickBooks.
- You can choose from existing employees and suppliers present in your QuickBooks or choose to add a new one by clicking on + add new.
- 11. A right side drawer opens where you can add the new supplier or employee. You can switch between adding a supplier or employee using the contact type field in the drawer.
- **12.** Enter the contact details of the supplier or employee, and then select **Save**.
- **13.** With the employee or supplier details entered, they will now appear in the sync your team member pop-up and select **Sync**.
- 14. Select Send invitation.



#### Turning on expense submission notifications

**Note:** All administrators in QuickBooks Online Advanced will receive an email notification.

- 1. In QuickBooks Online, go to Expenses, then Expense claims.
- 2. Select Manage settings.
- 3. Select Notify me when an employee submits an expense.
- 4. Select Done.






#### Managing expense categories

Set up category nicknames so it's easier for your employees to assign the correct category to an expense.

- 1. In QuickBooks Online, go to Expenses, then Expense claims.
- 2. Select Manage settings.
- **3.** Select **Manage categories** to edit categories employees can select.
- **4.** Enter a nickname, then choose the category it belongs to.
  - **a.** For example: Use the nickname "Client meals" for the "Meals & Entertainment" category to keep it simple.

#### 5. Select Save.

- **6.** In the Action column, select **Edit** if you need to make any changes to that category.
  - **a.** Select **Make inactive** to remove that category from employee view.
  - b. To hide/view any previously disabled categories, select the gear icon, then Show inactive or Hide inactive.








#### **Reviewing claims and create expenses**

- 1. In QuickBooks Online, go to **Expenses**, then **Expense claims**.
- 2. In the For review tab, select a receipt.
- **3.** Review the details, add info, select/enter sales taxes, and make any necessary adjustments.
- 4. Select Save and next, then Create expense.





#### Submitting expenses as an employee



#### Mobile

- 1. On your mobile device, open a web browser<sup>\*</sup> and sign in to QuickBooks.
- \*Note: Expenses claims cannot be submitted through the QuickBooks mobile app. You can use a mobile web browser.
- 2. Go to Expenses, then Expense claims.
- 3. Select New expense claim.
- 4. Do one of the following:

To take a photo or choose an image from your photo library, select **Use receipt capture**.

- a. Make sure the photo looks good, then select Next.
- b. Make sure the info pulled from the receipt is correct, and make adjustments if necessary.\*
- Note: The expense 'Amount' should include sales taxes paid.
  - c. (Optional) Select I need to be reimbursed.
  - d. Add the supplier, category, and business purpose.
  - e. Select Submit for review.

If you don't have a receipt, select Enter expense manually.

- a. Enter the amount.
- b. (Optional) Select I need to be reimbursed.
- **c.** If necessary, add the transaction date.
- d. Add the supplier, category, and business purpose.
- e. Then select Submit for review.



#### Computer

- Sign in to QuickBooks Online, go to Expenses, then Expense claims.
- 2. Select New expense claim.
- **3.** Do one of the following:

To choose a file or photo, go to Upload receipt.


- a. Select the receipt to upload.
- **b.** Make sure the photo or file looks good, then select Upload.
- c. Make sure the info pulled from the receipt is correct, and make adjustments if necessary.\*

- d. (Optional) Select I need to be reimbursed.
- e. Add the supplier, category, and business purpose.
- f. Select Submit for review.

If you don't have a receipt, select Enter expense info manually.

- a. Enter the amount.

- c. If necessary, add the transaction date.
- d. Add the supplier, category, and business purpose.
- e. Then select Submit for review.





### **Performance Centre**

Every business tracks unique metrics to measure its performance. Within the Performance Centre, your clients can create a custom dashboard as well as custom charts to track what matters most to their business. The Performance Centre is a central repository where businesses can:

- Track unique metrics to measure business performance.
- Create and customise charts to track what matters most to the business.
- Easily create a chart from scratch or customise one of the templates provided.



#### Create a custom chart from scratch

- 1. Select +Add new chart.
- **2.** Select the metric you want this chart to track. Then select Continue.

This opens a customization window. As you make selections, the preview updates to show you exactly what the chart will look like.

- 3. Give your chart a name.
- Select the type of chart, such as Trend line, Vertical bar, or Pie chart. These options vary based on the metric.
- **5.** In the **Time period** dropdown, select the time period you want to track.
- 6. In the Group by dropdown, select the category you want to group your data by. You can group by classes, suppliers, locations, or other categories. In the Select from multiple dropdown, select the items in the category you want to track. These are what appear in the bars or lines of the chart.

- If you want to see only data from a specific category, select it in the Filter by dropdown. Then use the Select from multiple dropdown to narrow it to items in that category.
- Tip: The Group by dropdown determines the type of data the chart will track. The Filter dropdown is where you decide what specific data is included. For instance, you may only want to see data when it applies to specific classes or locations. You can have up to 10 filters.
- To compare the results over different time periods, select Compare. Then select Previous period or Previous year same period. For some charts, you can also compare against a budget or goal.
- 9. When you're done, select Add to Dashboard.

When you go back to the Performance Centre, you'll see your new chart.

#### Edit or delete a chart

Success metrics always need fine-tuning. You can adjust your charts at any time:

- 1. Go to Reports.
- 2. Select the Performance Centre tab.
- 3. Find the chart.
- 4. Select the vertical ellipsis: on the chart and then Edit chart.
- **5.** Make the changes you need. Then select **Save**.
- 6. To delete the chart, select **Delete chart**.


### **Custom Fields**

Enhanced custom fields in QuickBooks Online Advanced tracks specific details important to your clients business. You can create custom fields for almost anything e.g. sales reps, customer types, supplier IDs, and more. You can then add your custom fields to sales forms, purchase orders, expense forms, customer profiles, and supplier profiles.

Custom fields can also be used to organise lists, narrow search results, and filter financial reports. Track the little things to get the big picture:

- Create more detailed reports with multiple field types.
- Search, sort, and filter the data you need, faster.
- Add up to 12 custom fields per form.

Note: Up to 156 unique active custom fields are available across Sales Receipts, Invoices, Quotes, Credit Memos, Refund Receipts, Purchase Orders, Expenses, Bills, Cheques, Supplier Credits and Credit Card Credits transaction forms, as well as Customer and Supplier profile forms.



#### **Creating custom fields**

You can have up to 12 active custom fields for each type of form (invoice, quote, purchase order, expense, bill, and so on), and each type of profile (customer and supplier).

Besides text, you can also create custom dropdown, date, and number fields.

- 1. Go to Settings 🕸. Then select Custom fields.
- Select Add custom field. If you've already created a field, you'll see Add field instead.
- 3. Give your custom field a name.
- Select the type of data that will go in your custom field: Text and number, Number, Date, or Dropdown list. If you select Dropdown list, enter the items in the list.
- 5. Select the category the custom field belongs to: Customer, Transaction, Supplier, or Project. Customer fields are for customer profiles, and supplier fields are for supplier profiles. You can assign transaction fields to sales forms (like invoices, quotes, and sales receipts) and purchase forms (like purchase orders, bills, expenses, and cheques).
- **6.** Select the forms where you want the custom field to appear.
- Note: To use custom fields in purchase orders, you need to turn on purchase orders for your company first.
- 7. If you want customers or suppliers to see the field on a form (such as invoices, estimates, or purchase orders), turn on the **Print on form** switch.



- Note: Out of a total of twelve available custom fields per transaction-type form, only three fields can be shown/printed.
- 8. When you're finished, select **Save**.

Now that you have custom fields, learn about how you can use them:

- Search and sort with custom fields
- <u>Use custom fields for suppliers and expenses</u>
- Use custom fields in reports



#### Manage your custom fields in one place

The custom fields page lists all your custom fields so you can manage them easily. To see it, go to **Settings** 愈, then select **Custom fields**.

For each custom field, you can see what category it applies to and which forms it appears in. You also see the Print icon if the custom field is visible to customers or suppliers on a form.

To edit a custom field:

- 1. In the Actions column, select Edit.
- **2.** Edit the field's name, select the forms it appears on, and choose whether it's visible to customers or suppliers.
- **3.** When you're done with your changes, select **Save**. Any edits you make here apply to all forms that use the field.

To make a custom field active or inactive:

- 1. Select the **arrow** next to Edit.
- 2. Select Make active (or Make inactive).
- **3.** Select **Yes** in the pop-up message to confirm your choice.



### Don't worry about losing inactive custom field data

If you make a custom field inactive, your past data won't disappear. You'll still see the field on sales forms and purchase orders you've used it on, but it won't appear on new forms.



#### Create or edit custom fields from a form or profile

You can also create and edit custom fields from any sales form, purchase order, expense form, customer profile, or supplier profile.


From a sales form (invoice, sales receipt, expense) or purchase form (expense and purchase order):

- 1. Open an existing form or create a new one.
- Select the Gear icon at the top of the form (not on the navigation bar). This opens a panel with the Custom fields section.
  - To create a custom field, select **+ Add custom field**. Fill out the info about the field, then select **Save**.
  - To edit an existing field, select the pencil icon next to the field. Or, select Manage custom fields. This opens the Custom fields page so you can make edits. When you're done making changes, close the window to return to the form.

### **Custom Reports**

QuickBooks Online Advanced makes it possible for you and your clients to build custom reports in addition to the hundreds of ready-made reports available. This allows you and your clients to easily view company financial data and insights to better run their business. Using custom reports you can:

- Select and sort reports by group filter to suit you and your clients needs.
- Create pivot tables and group data for easier analysis.
- Save reports for future reference.

#### **Creating a custom report**





### **Revenue Recognition**

Get a more complete and accurate view of your clients finances with deferred revenue automatically reflected in the books. Record customer payments for future services and QuickBooks Online Advanced will automatically recognize the revenue over the predefined period.

Using the revenue recognition feature in QuickBooks Online Advanced, you can:

- Set up a service to invoice once and recognise the revenue each month.
- View when revenue will be recognised, what the balance of the liability account will be, the amount you'll recognize and the total amount you'll have recognised at that time.

#### Why Revenue Recognition is important

Here are some business models that may use revenue recognition.

Business Model	Product or Service Example
Subscription based	A wine club charges a membership fee on top of subscription fees and wants to recognize the membership revenue upfront, but defer wine subscription revenue until they can deliver to the customer.
Project based / contractors	A project-based business or a contractor, who charges their customers upfront, wants to recognize some of the revenue only when that part of the job is complete.
Software	A hosted software company that charges \$240 yearly and recognizes \$20 every month until the software agreement ends.
eCommerce	E-commerce businesses receive payment upfront, but recognize the revenue upon delivery.
Pre-paid Billing	An insurance company charges an annual premium at a discount, but the revenue is recognized monthly.
Consulting Services / Law Firms	A law firm charges their client a retainer fee before rendering services and wants to recognize the revenue only when the work is complete.

- 1. Go to Sales, then Products & services.
- 2. Select New, then select Service.
- **3.** Fill out the details.
- Check "I recognize revenue for this product" and select the frequency (for example, daily or monthly).
- **5.** Choose a **Liability account**, and in **Service Duration** enter the number of days, weeks, months, or years over which the revenue should be recognized.
- Note: You can enter up to 1826 days for daily frequency, up to 260 weeks for weekly frequency, up to 60 months for monthly frequency, or up to five years for yearly frequency.

# More about service interval and frequency



Service Interval and Duration define how a company sells their product/ service. For example: An annual subscription sold at \$1200 can be set up as 12 months or 52 weeks.



#### Revenue Recognition Frequency is

how often you recognize revenue for a product or service. It's automatically set to monthly, but you can change it at any time. Once updated, it applies to all the future transactions. For example, an annual subscription sold at \$1200 with a daily frequency will be prorated based on the number of days in a month.



**Posting Frequency** is when we post the recognized amounts to the books. We post all automatic revenue recognition entries at the end of the month.

### How the posting frequency is calculated every month

For a service item that is priced at \$1200, the recognized revenue will be automatically moved to the income account at the end of the month. The monthly recognized amount varies depending on the recognition frequency selected in Settings. **Formula:** Total price of the item / # of frequencies for the duration \* # of frequencies per month.

Here's an example of how the recognized revenue is calculated and posted at the end of the month for different frequencies:

Frequency Selected	Recognized Amount (at the end of the month)
Monthly Example	1200 / 12 * 1 = 100
Weekly Example (When 4 weeks in a month)	(1200 / 52) * (4) = 92.30
Weekly Example (When 5 weeks in a month)	(1200 / 52) * (5) = 115.38
<b>Daily Example</b> (When 31 days in a month)	(1200 / 365) * 31 = 101.91
<b>Daily Example</b> (When 28 days in a month)	(1200 / 365) * 28 = 92.05

### **Backup and Restore company data**

With QuickBooks Online Advanced, your clients data is automatically backedup and stored securely in the cloud. This ultimately means you can restore data to resolve unwanted changes and to fix mistakes. Using the backup and restore app you and your clients can:

- Set up automatic and continuous backups.
- Restore data to a specific date and time, and track changes with history logs.
- Take a manual backup at any time.
- Make a copy of the QuickBooks Online Advanced file for another level of security.
- Export the file's data into a CSV file for another level of data security.

#### What data you can and can't back up

While you can back up data related to your chart of accounts, there is some data you can't back up. Here's a list of data you can and can't back up.

#### Data you can't back up

Some data can't be backed up. Since this data is non-posting, it won't affect your accounts:

- QuickBooks Online Payments info.
- Customer types and price rules.
- Delayed credits and charges (although associated invoice are backed up).
- Recurring transactions.
- Bank feeds and their links to transactions and bank rules.
- Reconciliation reports.
- Account-based billable expenses.
- Item-based billable expenses with markup.
- Custom reports.
- Custom form templates.
- Audit log entries.



#### Data you can't restore

When you restore a backup, you can restore everything except:

- **Budgets** you need to export them as a CSV file.
- **Inventory** it doesn't include the inventory history and inventory adjustments.
- Tax rates using expense accounts the Online Backup and Restore app restores them in your liability accounts.
- Data backed up using the Local Backup feature This data is saved in .cab format on your personal cloud account; Google Drive or Dropbox, for example. Restoring the data from a local backup is not supported at this time.

#### Turning on Backup and Restore

When you turn on the Online Backup and Restore app, QuickBooks automatically backs up your data. Once it's complete, it'll track any changes made to your company data. You can restore a backup at any point in time.



Maybe you're in the middle of an important project and want to save everything. No problem. You can do a manual backup anytime. Here's how.

- **1.** Sign in to the QuickBooks Online Advanced company you want to back up, as an admin.
- 2. Go to Settings 🕸 and select Back up company.
- Note: You might need to sign in with an Intuit account to proceed.
- 3. Select Backup from the menu.
- 4. Select New Manual Backup.
- 5. Select the company you want to manually backup.
- From the Backup Type dropdown ▼, select Incremental, Full, or Complete.
- Note: The Incremental option only saves changes since your last backup. Full saves your financial data. Complete saves everything, including your company data.
- 7. Select Request Backup.

#### Save your backups to Dropbox or Google Drive

QuickBooks Local Backup is a convenient feature that enables you to export essential business data such as invoices, customers, and bills to Excel. It's an excellent tool for archiving historical data that can be easily accessed and shared with external stakeholders like accountants. You can save your data to your personal Dropbox or Google Drive.

However, it's important to note that Local Backup cannot be restored. So, while it's a great way to keep track of past records, it cannot be used to recover lost or damaged information.



- 1. Go to Settings 🕸 and then select Back up company.
- Note:You might need to sign in with an Intuit account to proceed.
- 2. Select Local Backup.
- 3. Select Link a Service.
- 4. Select Link Google Drive or Link DropBox.
- **5.** Follow the steps to allow QuickBooks to create the backups.
- Note: Data saved using Local Backup cannot be restored using Online BackUp and Restore at this time.



#### Restoring your data from a backup

Use the backup to restore your data from a specific date and time. It may take up to an hour to restore a backup, but it usually takes much less. The fewer data the company has, the faster it takes.

#### Important

Don't do anything in your company while the Online Back-up & Restore app restores your data. When it's ready, you'll see a checkmark in the status. That's when it's safe to go back and use your company.

- **1.** Sign in to the QuickBooks Online Advanced company you want to restore, as an admin.
- 2. Go to Settings 🕸 and select Back up company.
- Note: You might need to sign in with an Intuit account to proceed.
- 3. Select Restore, then select New Restore.
- From the Select the company dropdown ▼, select the company you want to overwrite and restore accounting data to.
- **5.** From the **Date** field, select the date you want to restore to.

- From the Time dropdown ▼, select the time you want to restore to.
- 7. Enter "AGREE" in Ready to restore your backup?
- **8.** Select **Next**. If you see a list of recommended actions, follow them first. After you finish everything on the list, select **Refresh to continue**.
- 9. Select Start Restore.

It takes about 5 - 10 minutes to restore your data. Depending on the amount of data, it can take up to an hour.

### **Custom Role Permissions**

**Control access to sensitive areas in QuickBooks Online Advanced using the new role permissions** feature. You and your clients can choose from predefined role options or create new roles with the required permissions. Set access permissions by assigning a role like sales manager, payroll manager or front-of-house to a team member or tailor their access individually.

Using role permissions you can:

- Delegate work, protect sensitive data, and manage user access with custom roles.
- Preview their access to confirm each user can only see and do what they need to.

#### Adding and managing custom roles

With custom roles, your clients can manage user access in QuickBooks and give users only the access needed for their role. Choose what users can see and do within different areas of QuickBooks like banking, sales, payroll, expenses, reports, and inventory.

Note: Only administrators can set up custom roles plus some fields are read only and are automatically included in a role.

When you set up a new role, you have the option to:

- Create a new role and choose what the role can access.
- Choose a predefined custom role, like Sales Manager or Expense Manager.
- Choose from the list of QuickBooks roles, like Company admin or Time tracking only.
- Add a new role.
- Create a sales role by location.
- Assign a role to a new user.
- Assign a custom role to a new user.
- Edit access for a role.
- Edit a user's role.
- Reactivate or deactivate a user's role.
- Custom roles and access.



#### Add a new role

If you'd like to create a new custom role, you just need to add the role and choose the different areas the role can access.

- 1. Go to Settings 🕸, then select Manage users.
- 2. Select the Roles tab, then select Add role.
- 3. Enter a Role name and Role description.
- Select what the user role can access in QuickBooks, then select Save Role.

#### Create a sales role by location

If you have businesses across different locations, you can create a role with different sales access for each. This way, your users can manage sales transactions based on their location.

- Note: If you haven't yet, make sure to set up and add a location for your company.
- 1. Go to Settings 🕸, then select Manage users.
- 2. Select the Roles tab, then select Add role.
- 3. Enter a Role name and Role description.
- 4. Select Sales.
- **5.** From the **All locations** drop-down menu, select one or more locations.
- 6. Select what your user can access.
- 7. Select Save Role.



#### Assign a role to a new user

If you have a new user, you'll need to add them in QuickBooks and assign a role.

- 1. Go to Settings 🕸, then select Manage users.
- 2. Select Users tab, then select Add user.
- 3. Enter the user's First name, Last name and Email.
- **4.** From the **Roles**, dropdown menu, select the role you want to assign to the user.
- **5.** Review the permissions this role has and select **Send invitation**.

The user will get an email invite and will need to select **Let's go!** to sign in.

#### Assign a custom role to a new user

Assign a custom role to a new user.

- 1. Go to Settings ô, then select Manage users.
- 2. Select the Users tab, then select Add user.
- 3. Enter the user's First name, Last name and Email.
- **4.** From the **Roles**, select **View all permissions**, then assign the custom permissions you want to assign to the user.
- **5.** Review the permissions, then select **Send invitation**.
- You'll be asked to Create a custom role, since you have used custom permissions.
- 7. Enter the Custom role name and Role description.
- 8. Select Save Role.

The user will get an email invite and will need to select **Let's go!** to sign in.

Note: If your user forgot their password, they can reset their own password.





#### Edit access for a role

Once the user accepts your email invite, you can edit the access of the roles you created at any time. Here's how.

- 1. Go to Settings ô, then select Manage users.
- 2. Select Roles tab. In the Action column, select Edit.
- **3.** Select access for a role.
- 4. Enter a Role name and description, then select Save Role.

#### Edit a user's role

Sometimes your user's roles will change or you may need to allow a user more access. Here's how to edit a user's role.

- 1. Go to Settings 3, then select Manage users.
- 2. Select Users tab, then find the user you want to edit.
- 3. Select Edit from the Action column.
- **4.** Choose from the existing custom or QuickBooks roles.
- Select Save. If you edited permissions after selecting the role, you'll be asked to save a new custom role. Enter a Role name and description, then select Save Role.

#### Reactivate or deactivate a user's role

You can activate or deactivate a user role if needed. But before you can make a role inactive, you have to assign any associated users to a different role.

- 1. Go to Settings ô, then select Manage users.
- 2. Select the **Roles** tab, then find the role you want to edit.
- 3. In the Action column, select : next to Edit.
- 4. Select Deactivate.

If the user role is already deactivated, select **Reactivate**. Then select **Reactivate Role**.

If you need to reduce your users, you can delete them so you won't reach your usage limit. <u>Learn more about</u> <u>usage limits</u>.
